# Audit Overview

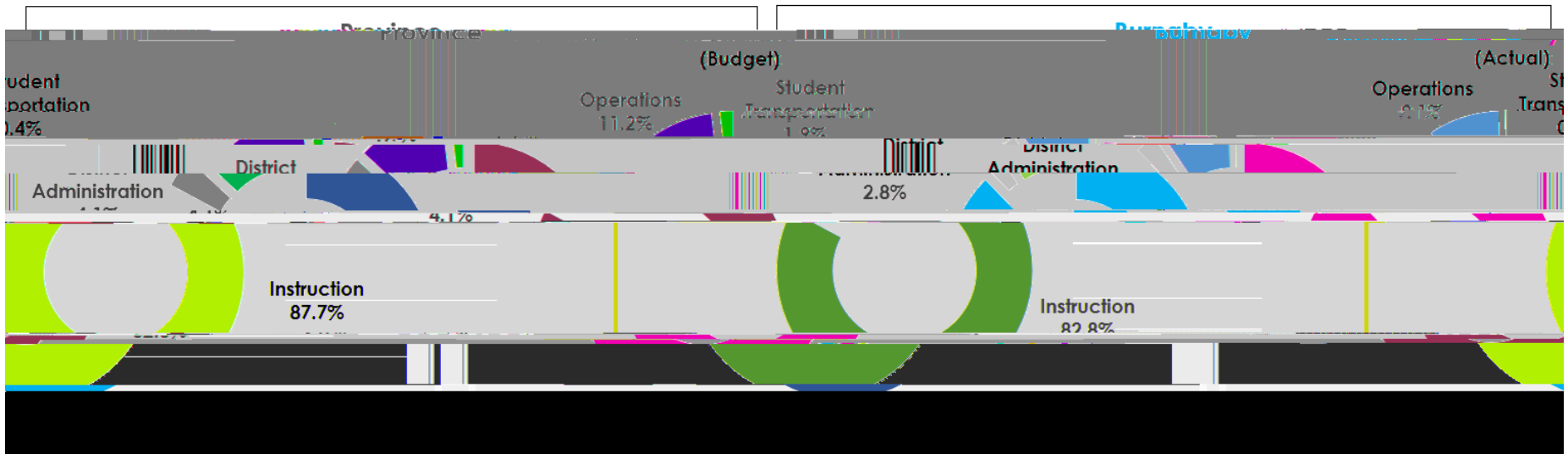
- The School Act requires that school district financial statements be externally audited
